ORDINANCE

Imphal, the 4th September, 1996

No. 3 of 1996

No VC CAU/14(ESTABLIS)-93: In exercise of the powers conferred by sub-section (2) of section 27 read with clause (a) of sub-section (1) of the said section of Central Agricultural University Act, 1992 (No. 40 of 1992), I, the Vice-Chancellor of the Central Agricultural University, Imphal, with the prior approval of the central Government Indian Council of Agricultural Research, vide their letter No.F.42-1(8).94-Edn. 4V dated the 21st August, 1996 hereby make the first Ordinance and notify the reservation of seats for admission in Under-Graduate courses in the Central Agricultural University, Imphal, as follows, namely:

1. All Under-Graduate
Programmes:

Fifteen per cent of the total seats provided for the six states of North-East Region in Under-Graduate Programmes of different colleges of the Central Agricultural University, Imphal, shall stand reserve for the candidates selected from an examination to be conducted on all India basis by Indian Council of Agricultural Research. This shall be over and above the seats provided for the six states of North-East Region.

2. Post-Graduate Programmes

Twenty-five per cent of the total seats provided for the six states of North-East Region but not less than one in each course, in all Post-Graduate Programmes of different Colleges of the Central Agricultural University, Imphal, be reserved for the candidates selected from an examination to be conducted on all India basis by Indian Council of Agricultural Research. This shall be over and above the seats of North-East Region.
