NOTIFICATION
(INCOME TAX)

No. 7249 (F.No.261/14/87-ITJ): In exercise of the powers conferred by sub-section (1) of Section 121A of the Income-tax Act, 1961(43 of 1961) and in modification of the previous notification No.6585 (F.No.261/2/86-ITJ) dt.6.2.85, the Central Board of Direct Taxes hereby directs that the Commissioner of Income-tax(Appeals) of the Charges specified in Column (1) of the Schedule below, shall perform their functions in respect of such persons, assessed to Income-tax or Sur-tax or Interest-tax in the Income-tax Wards, Circles, Districts and Ranges specified in the corresponding entries in column (2) Column (3) thereof as are aggrieved by any of the orders mentioned in Clauses (a) to (h) of sub-section (2) of Section 246 of the Income-tax Act, 1961, in sub-section (1) of Section 11 of Companies (Profits) Sur-tax Act, 1964(7 of 1964) and in sub-section (1) of Section 15 of the Interest Tax Act, 1974(45 of 1974) and also in respect of such persons or classes of persons as the Board has directed or may direct in future in accordance with the provisions of clause (1) of sub-section (2) of Section 246 of the Income-tax Act, 1961.

Whereas Income-tax Circle, Ward or District or Part thereof stands transferred by this notification from one charge to another charge, appeals arising out of assessments made in that Income-tax Circle, Ward or District or Part thereof and pending immediately before the date of this notification before the Commissioner of Income-tax of the charge from whom the Income-tax Circle, Ward, or District or Part thereof is transferred shall from the date of this notification takes effect, be transferred to and dealt with by the Commissioner of Income-tax of the charge to whom the said Circle, Ward or District or Part thereof is transferred.

This notification shall take effect from 1-4-1987.
