NOTIFICATION
INCOME-TAX

No. 1451 (F.No.261/3/76-IT) : In exercise of the powers conferred by sub-section (1) of section 122 of the Income-tax Act, 1961 (43 of 1961) and of all other powers enabling it in that behalf and in partial modification of all previous notifications in this regard the Central Board of Direct Taxes hereby directs that the Appellate Assistant Commissioner of Income-tax of the ranges specified in Column 2 of the Schedule below shall perform their functions in respect of the persons and incomes assessed to Income-tax or Super tax in the Income-tax Circles, Words and Districts specified in the corresponding entry in Col. 3 thereof:-


