NOTIFICATION
INCOME TAX

No. 1453 (F.No. 203/153/81-IIA.II): It is hereby notified for general information that the institution mentioned below has been approved by the Indian Council of Social Science Research, the prescribed authority for the purposes of clause (iii) of sub-section (1) of section 35 of the Income-tax Act, 1961, subject to the following conditions:-

- i) That the funds collected by the Manipal Institute of Management, Manipal under this exemption shall be utilized exclusively for promotion of research in Social Sciences.
 - ii) That the Institute shall maintain a separate account of the funds so collected by them under this exemption and shall send to the Council an Annual Report of its activities along with the Statement of Accounts regularly showing specifically the funds collected under this exemption and the manner in which these funds are utilized.
 - iii) Any unutilized funds, out of the donations received under section 35(1)(iii) of Income-tax Act, 1961, will be invested in the manner prescribed in section 13(1)(d) which includes investment in Govt. Saving Certificates, deposit in scheduled Bank, investment in U.T.L., deposits with the Public Sector Companies, deposits in Post Office and Govt. Companies etc.
 - iv) That the Institute shall submit to the Prescribed authority by 30th June each year a copy each of their audited annual accounts showing their total income and expenditure and balance sheet showing its assets and liabilities with a copy of each of these documents to the concerned Commissioner of Income-tax.
