NOTIFICATION
INCOME TAX

No. 876 (F.No.203/ 10 / 88-ITA.II): In continuation of this Office Notification No. 7015 (F.No.203/ 229/ 85 -ITA.II) dated 19-11-86 ~~it~~ is hereby notified for general information that the Institution mentioned below has been approved by Department of Scientific & Industrial Research, New Delhi, the Prescribed Authority for the purposes of clause (1) of sub-section (1) of Section 35 (Thirty Five/One/ ~~Two~~) of the Income-tax Act, 1961 read with rule 6 of the Income-tax Rules, 1962 under the Category "Association" subject to the following conditions:-

- i) That **Hexamar Agricultural Research and Development Foundation, Hexamar House, Sayani Road, Bombay-25** will maintain a separate account of the sums received by it for scientific research.
- ii) That the said **Association** will furnish annual returns of its scientific research activities to the Prescribed Authority for every financial year in such forms as may be laid down and intimated to them for this purpose by 31st May each year.
- iii) That the said **Association** will submit to the Prescribed Authority by 30th June each year a copy of their audited annual accounts showing their income and expenditure and Balance Sheet showing its assets and liabilities with a copy of each of these documents to the Central Board of Direct Taxes, New Delhi, DGIT (Exemption) Calcutta and the Concerned Commissioner of Income-tax.
- iv) That the said **Association** will apply to Central Board of Direct Taxes, Ministry of Finance (Department of Revenue), New Delhi and DGIT (Exemption) Calcutta ~~at least 60 days in advance~~ before the expiry of the approval for further extension, Applications received after the date of expiry of approval are liable to be rejected.
