NOTIFICATION
(INCOME-TAX)

No. 3273 (F.No. 189/13/78-II(AI)): In exercise of the powers conferred by sub-section (1) of section 121 of the Income-tax Act, 1961 (43 of 1961) and in supersession of all previous Notifications in this regard, the Central Board of Direct Taxes hereby direct that the Commissioner of Income-tax specified in column 1 of the Schedule hereto annexed with headquarters specified in column (2) thereof shall perform his functions in respect of such areas or of such persons or classes of persons or of incomes or classes of incomes or of such cases or classes of cases as are comprised in the Income-tax Circles. Wards or Districts referred to in the said column (3):

Provided that the Commissioner of Income-tax shall also perform his functions in respect of such persons or of such cases as have been or may be assigned by the Central Board of Direct Taxes to any Income-tax authority subordinate to him:

Provided further that the Commissioner of Income-tax shall not perform his functions in respect of such persons or such cases as have been or may be assigned to any Income-tax authority outside his jurisdiction.
