No. 3105 (F.No.261/20/79-ITJ); In exercise of the powers conferred by sub-section(1) of Section 122 of the Income-tax Act, 1961(43 of 1961) and in supersession of all the previous notifications including notification No.3061 dated 6.11.1979 in this regard, the Central Board of Direct Taxes, hereby directs that Appellate Assistant Commissioner of Income-tax of the Ranges specified in column(1) of the Schedule below, shall perform their functions in respect of all persons and income assessed to income-tax in the Income-tax Circles, Wards and Districts specified in the corresponding entry in column (2) thereof excluding all persons and income assessed to Income-tax over which the jurisdiction vests in Commissioner of Income-tax(Appeal:




