In addition, he shall have completed a research project and submitted to the Faculty a creditable thesis.</p>	<p>IGKV has adopted the new and revised P.G. and Ph.D. Course curricula after recommendation from Academic Council and from Board of Management in its 73<sup>rd</sup> meeting held on 22.10.2009. The new guidelines as suggested by ICAR has modified the minimum credit requirement for PG and Ph.D. Programme. Hence, amendment has been proposed in Statute 61, in reference to sub-section (6) of section 39 of IGKV Act 1987. The amendment needs an approval from His Excellency the Chancellor of IGKV, Raipur. Therefore, it may be forwarded to HE the Chancellor of IGKV, Raipur for kind approval.</p>
