In partial modification of Circulars No. 22 dated 06/11/2013, No. 26 dated 20/11/2013 and No. 27 dated 29/11/2013 of 2013-14 and in exercise of the powers conferred under rule 49A of the Delhi Value Added Tax Rules, 2005, I, Prashant Goyal, Commissioner, Value Added Tax, do hereby extend the last date for online filing of return for 2<sup>nd</sup> quarter of 2013-14, including Block R 10 of CST Return in Form 1 for the year 2009-10, 2010-11, 2011-12 and 2012-13, upto 31<sup>st</sup> December, 2013. The print/hard copy of the acknowledgement in Form DVAT 56 should also be submitted upto 3<sup>rd</sup> January, 2014.

The dealers who have filed the second quarter return of 2013-14 in the old format shall file the return in the amended format for the 2<sup>nd</sup> quarter return by the aforesaid dates.
