G. O. (P) No. 363/95/GAD. Dated, Thirtyvananthapuram, 29th September, 1995.

S. R. O. No. 1165/95.—In exercise of the powers conferred by sub-section (i) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) and in supersession of all the existing rules and orders on the subject, the Government of Kerala hereby make the following Special Rules for the Kerala Tourism Service, namely:—

RULES

1. Short title and commencement.--(i) These rules may be called the Special Rules for Kerala Tourism Service, 1995.

(ii) They shall come into force at once.

2. Constitution.—The service shall consist of the following categories of officers, namely:—

6. Qualifications.—(a) No person shall be eligible for appointment to the category specified in column (1) of the Table below by method specified in column (2), unless he/she possesses the qualification specified in the corresponding entry in column (3) thereof.


(b) The experience prescribed for direct recruitment to the various categories shall be the one gained after acquiring the basic academic or other. qualifications specified for the respective posts. The Scheduled Castes and Scheduled Tribes candidates who are selected to the post shall acquire the experience qualification within the period of probation specified for respective posts.

(iii) Should have the ability to prepare Tourist Literature/Brochures etc. Preferential Should have an attractive personality, should be resourceful and well informed, should be capable of moving with foreigners and should be able to speak English fluently. Knowledge of other language also will be considered desirable, should possess a good knowledge about Kerala in particular and India in general. These qualifications shall be within the meaning of G. No person shall be eligible for appointment by direct recruitment to the post of Tourist Information Officer, Manager Grade I if he/she has not completed the age of 20 years as on the 1st day of January of the year in which the applications for the appointment are invited. Relaxation of upper age limit envisaged in Rule 10 (c) of Part II of Kerala State and Subordinate Service Rules, 1958 shall be applicable for selection by direct recruitment under these rules.

Every person appointed to any of the categories specified in Rule 2 shall, from the date on which he/she joins duty, be or probation.

- (i) If appointed by direct recruitment or by transfer for a total period of two years on duty within a continuous period of three years, and
- (ii) If appointed by promotion for a total period of one year on duty within a continuous period of two years.

Every person appointed shall within the period of probation pass Account Test (Lower) and Manual of Office Procedure unless he has already passed the same.

The post of Manager Grade I shall be security post and fidelity insurance cover for Rs. 1000 (Rupees one thousand only) shall be obtained from the State Insurance Department.
