
No.IIE-FE-IV(A)-POL-0042/2014 ୫୩୭ /HE.. In exercise of the powers conferred by sub-section (4) of section 7-C of the Orissa Education Act, 1969 (Orissa Act 15 of 1969), the State Government do hereby make the following order to amend the Orissa (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2008 to regulate the payment of Grant-in-Aid in shape of Block Grant prospectively, namely:-

1. (1) This Order may be called the Odisha (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid (Amendment) Order, 2016.
- (2) It shall apply to the Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools.
- (3) It shall come into force on the date of its publication in the Odisha Gazette.
2. In the Orissa (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2008, the following provision shall be inserted as para-5 after para-4 of Annexure-II.

“The posts of Laboratory Attendant in a Junior College/Degree College are eligible to receive Block Grant.”

Order: Ordered that this Notification shall be published in an extraordinary issue of the Odisha Gazette.


