ORDER**

Jaipur, November 17, 2016

No. F.3(6) Esst/RLA/1991 Part-III/2008-16/47268-72.- In exercise of the power conferred under Rule 4(2) of the Rajasthan Legislative Assembly Secretariat (Recruitment and Conditions of Service) Rules, 1992 Hon'ble Speaker, Rajasthan Legislative Assembly hereby issue the following order to make the amendments in the schedule, namely :-

1. Short title and commencement :-

- (a) These Rules may be called the Rajasthan Legislative Assembly Secretariat (Recruitment and Conditions of Service) (Amendment) Rules, 2016.
(b) They shall come into force with immediate effect.

2. Amendment in Schedule :-

(1) under heading "Rajasthan Vidhan Sabha Secretariat Ministerial Service", the existing entries in column number 4, against serial number 6, shall be substituted by the following, namely :-

"(A) (a) in case of direct recruitment candidate must be graduate from any University established by Law in India.

(b) On the basis of competitive examination held with the speed of 100 w.p.m. in shorthand and 30 w.p.m. in typing on Computer.

AND

"O" or Higher Level Certificate Course conducted by DOEACC under control of the Department of Electronics, Government of India.

OR

Computer Operator & Programming Assistant (COPA)/Data Preparation and Computer Software (DPCS) certificate organized under National/State Council of Vocational Training Scheme.

OR

Diploma in Computer Science/Computer Applications from a University established by law in India or from an institution recognized by the Government.

OR

Diploma in Computer Science & Engineering form a Polytechnic Institution recognized by the Government.

OR

Rajasthan State Certificate Course in Information Technology (RSCIT) conducted by Vardhaman Mahaveer Open University, Kota under control of Rajasthan Knowledge Corporation Limited.

(B) In case of selection from agongst staff the candidate must have been working as Clerk Grade-I

/Clerk Grade-II/Tehephone

Operator in Rajasthan Vidhan Sabha Secretariat and must have passed the qualifying examination ."
