NOTIFICATION

In exercise of the powers conferred by Guideline 4.2 of the Guidelines for extraction of trees from non-forest areas, the Government of Tripura hereby adds the following to the tree species mentioned in Guideline 4.1 (a) for which permission for extraction from the Forest Department is not required:

‘Agar (*Aquilaria malaccensis*)’
