WHEREAS Government Notification no.-2034/IX-1-2020-13T.A./20 dated December 04, 2020 was issued and published in the Gazette on the same date with a view to invite objections and suggestions from the general public with respect to the inclusion of the areas specified in the Schedules below in the transitional area of Nagar Panchayat Salon in District Raebareli as required by sub-section (1) section 4 of the Uttar Pradesh Municipalities Act, 1916 (U.P. Act no-II of 1916);

AND WHEREAS objections and suggestions received in pursuance of said notification were disposed of vide Government Order no.-1659/9-1-2022-13T.A./2020 dated June 28, 2022.

NOW, THEREFORE, in exercise of the powers under clause (2) of Article 243-Q of the Constitution of India read with sub-section (2) of section 3 of the Uttar Pradesh Municipalities Act, 1916 (U.P. Act no. 2 of 1916) and in partial modification of Notification no.-2371-T/9-A-45-T(1)-68, dated October 11, 1971 and other previous notifications issued in this behalf, the Governor having regard to the population of the area, the density of the Population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities, the economic importance and such other factors is pleased to include the areas specified in the Schedules below in the transitional area of Nagar Panchayat Salon in District Raebareli for the purposes of Part IX-A of the Constitution.
