And, WHEREAS, in para 4.1.2 of the U.P. Electric Vehicle Manufacturing Policy-2019 , Large Anchor EVMU/EBU and MSME units has been provided various promotions such as exemption in electricity duty as provided through U.P. Industrial Investment and Employment Promotion Policy of 2017.

NOW, THEREFORE, in exercise of the powers under sub-section(4) of section-3 of the U.P. Electricity (Duty) Act-1952 (U.P. Act no. 33 of 1952), the Governor, is pleased to direct that large Anchor EVMU/EBU and MSME units established under the U.P. Electric Vehicle Manufacturing Policy-2019 shall be exempted from Electricity Duty for a period of 10 years from the date of publication of this notification in the Gazette.
