IN exercise of the power conferred on it by Sections 61, 86(1) (e) and 181 of the Electricity Act, 2003 (36 of 2003) and all other powers enabling it in this behalf, the Uttar Pradesh Electricity Regulatory Commission has made UPERC (Rooftop Solar PV Grid Interactive System Gross/Net Metering) Regulation 2019, which were published *vide* notification no. UPERC/Secretary/RSPV Regulations/434(A) dated January 4, 2019.

AND WHEREAS, UPERC (Rooftop Solar PV Grid Interactive System Gross/Net Metering) Regulation, 2019 (First Amendment/Addendum) were published *vide* notification no. U.P.E.R.C./ Secretary/RSPV Regulations/118, dated June 1, 2022.

AND WHEREAS, the Government of Uttar Pradesh has framed UP Solar Policy 2022, which has to remain in operation for a period of five (5) years or till the Government notifies the new policy. In view of the UP Solar Policy 2022, Uttar Pradesh Electricity Regulation Commission, now in exercise of its power conferred under sections 61, 86 (1) (e) and 181 of Electricity Act, 2003 and clause 17 of the aforesaid Regulation *i.e.* Power to Amend and all other enabling powers hereby makes the following amendments, namely:-

1. Short Title and Commencement-

- (a) These Regulations shall be called UPERC (Rooftop Solar PV Grid Interactive System Gross/ Net Metering) Regulation, 2019 (Second Amendment) hereinafter referred to as RSPV Regulation, 2019 (Second Amendment).
- (b) These Regulations shall come into force from the date of their notification in the Official *Gazette* of the State.
